Commitment description	
What is the public problem that the commitment will address?	<p>The Law of the Kyrgyz Republic “On Normative and Legal Acts” dated July 20, 2009 № 241 establishes requirements for public discussion of draft normative and legal acts (hereinafter referred to as the NLA). Practice showed that the provisions of the Law on public discussions are ineffective and do not ensure the actual participation of citizens in the legislative process due to the following reasons:</p> <ul style="list-style-type: none"> - Absence of public planning of law-making process; - Regulations do not prescribe consideration of alternative options at the early stage of law - making and do not prescribe any regulating methods; - Absence of notification mechanism of stakeholders results in citizens incurring high costs while searching for the information of interest on the draft NLAs; - Absence of public mechanism to respond to stakeholder comments; - Absence of unified procedures that reflect the principles of public discussions of the NLAs.
